Annual Report for F.Y. 2021-2022

It gives us a great pleasure to submit the said report successfully completed in spite of the second-worst pandemic that affected the country. It was in the third week of April,2021 the severe acute respiratory syndrome coronavirus 2 started to spread more rapidly than ever and recorded a massive surge when the daily number of cases crossed the 2-lakh mark. The second wave of COVID-19 in India has severe consequences in the form of spiraling cases, reduced supplies of essential treatments, and increased deaths particularly in the young population. As the pandemic continued the only option was online webinars.

NISD permitted RRTC's to send online proposals and accordingly our proposals were granted. Therefore, most of activities for creating awareness and training the participants were through virtual medium (through internet on zoom platform.

We have attended Periodical meetings conducted by MSJE & NISD with RRTC's in the Year 2021-22.

The Details of the programs conducted are as under:

We would like to place on record that we received the mail of Annual Action Plan for the year 2021-2022 on 2nd June, 2022 by Ministry of Social Justice and Empowerment. On 15th June, 2021 we submitted the 45 programs. But NISD sanctioned only online 7 programs.

RRTC planned for the financial year 2021-22 as per Ministry Annual Action Plan.

Awareness, Training and Capacity building:

a. Creating a pool of trained personnel who can run the senior citizen homes as per the minimum standards and training to the Staff of the project of Senior Citizens Homes (Implementing Agency: NISD through RRTCs)-

We sent the proposal but not received the sanction order by NISD.

- b. Training on Geriatric Care & Health Care with the help of States/NISD –
 We have received the sanction order for four 3days Geriatric Care Training by NISD
- **c.** Awareness Generation and Sensitisation Programme spread over the country by implementing agencies (Reputed organisations, government or otherwise working in the field of Ageing)-

We received the sanctioned order for 5 online programs.

As per guidelines programs we conducted ONLINE webinar/video conferencing mode only. we conducted the programs online on zoom platform.

Summary of the 6 programs held with Maharashtra Police Training Academy:

The topics of the sessions enlightened the participants and it was extremely important for the police to know that the MWPSC Act, 2007 has three penal sections under which the police can file FIR, arrest (imprison) the abuser for elder abuse, cheating, fraud and their abandonment. They were made aware to visit old age homes to find out the elder abuse caused by relatives and also to help voluntary organisations for their hospitalization, covid vaccination, claiming of dead bodies and funerals etc.

The Police, Sr. Citizen groups and the participants understood how to use the NISD National Elder line 14567 in case of domestic or abandoned elder person. Janaseva Foundation from Pune has been selected to operate the above elder line for State of Maharashtra. For creating the awareness of the elder line, CSSC-RRTC organized district sessions and the Project Manager of Janaseva Foundation gave power point presentation and information of Elder line. He gave success stories of reunion of the elderly person who were found on the street. The Participants were motivated to take advantages of the above elder line to reconnect the lonely Sr. Citizens and also to help in any such manner which they can.

Summary of the 4 programs held with Maharashtra Distric Legal Services Authority:

Maharashtra Legal Services Authority directed the DLSA to conduct the district wise programs for creating the awareness in the society for the rights of Sr. Citizens under MWPSC Act, 2007. Accordingly, we conducted four awareness programs with help of resource persons, Tribunal (Sub Divisional) Officer (SDO's), Judicial officers, Fescom & NGO's.

The speakers enlightened the participants (Advocates, PLV's, Sr. Citizens, NGO's) that the justice is available to the needy Sr. Citizens who are deprived from their own properties and are homeless. This Act gives justice to the Sr. Citizens to get maintenance amount from the beneficiaries. There were many other provisions of the Act and various judgements given by the court were communicated to the participants. CSSC-RRTC assured them the advice help, guidance in future.

<u>Visit to Old age homes to understand the issues, difficulties:</u>

<u>CSSC-RRTC visited 5 non-funded old age homes during the above programs.</u>

- 1. Smit Old Age home, Thane, Maharashtra
- 2. Niwara Old Age home, Pune, Maharashtra
- 3. Divija Old Age home, Kankavali, Sindhudurg, Maharashtra.
- 4. Sahara Old Age home, Nashik, Maharashtra.
- 5. Swami Samarth Old Age Home, Alibag, Raigad, Maharashtra

Observations of Beneficiaries:

- 1. As per our observation most of the Sr. Citizens had blood relatives
- 2. More than majority of them were in old age home out of compulsion.
- 3. Some of them found on road had no govt. documents such as adhar card or any other identity.
- 4. Most of them were suffering from depression, dementia, other mental and physical diseases. (cancer, heart, diabetic, blood pressure etc.)
- 5. No visit by relatives was major reason for the depression.
- 6. Relatives were found deliberately dumping them into the old age home and not taking up their responsibilities such as old age home nominal charges, home visit, medicines etc.
- 7. Refusal to eat food and sometimes non-cooperation to the caregivers.

Observation of Old Age Home:

- 1. Shortage of funds to run the Organisation.
- 2. Non-cooperation from police, Govt. for govt. documentation.
- 3. Non-cooperation by nearby hospitals/Doctors in case of emergency.
- 4. Cooperation by NGO's, Sr. Citizens organization/Lion club/Rotary clubs etc.
- 5. Donation, sponsorship supply of medicines, groceries and essential items.
- 6. The management runs the old age homes in spite of many difficulties.

<u>Suggestions</u>: The Government needs to identify such old age homes which are poorly managed due to paucity of funds. The corporate sector needs to adopt old age homes to support the good cause. The college students, need to give voluntary services to help the abandoned elders. The society at large owe the responsibility to visit such homes on various occasions and can adopt a few Sr. Citizens.

- ➤ If the Ministry decides to submit the application for new projects, then accordingly, we give them the said information.
- ➤ We inform organization of GIA to apply for gap districts for new projects (old age home)
- ➤ We guide them for PFMS data entry.
- ➤ We frequently counsel them to maintain the old age home clean, neat, hygienic as per the standard mandate of MSJE.
- ➤ We give surprise visit to GIA old age home.
- ➤ We give technical advice to the management in case of updating the chart of Sr. citizens and informing the Ministry in case of death of existing beneficiary & registration of new admission.
- ➤ We give them technical guidance to display on their notice board the daily, weekly food chart. Keep available first aid box, medicines & display list of nearby hospital, doctors, police station, ambulance etc.



1. World Elder Abuse Awareness Day at CSSC Auditorium:

Mr. Borgaonkar presented the research carried out by Help Age India on Elder Abuse. CSSC-RRTC's helping hand to the National Elder Line in Maharashtra division:

National Helpline for Sr Citizen (Elder line-14567) has been made operational on **toll free number 14567** services to Sr. Citizens such as information of Doctors, Hospitals, Old Age Homes, and Activity centres etc. And also provide free information, guidance on pension, medical and legal assistance, besides giving emotional support, intervene in cases of abuse and rescue homeless elderly. In this respect we give helping hand to the staff of Janaseva Foundation as and when necessary. We also call them in our awareness programs and give them platform of reaching to the participants about the functioning of elder line 14567. Our noteworthy contribution was hospitalization in KEM, Mumbai to one female homeless elderly lady found on the street of Mumbai City (CST Station) in semi unconscious condition and was badly beaten by rodents. At present she is fully recovered due to the help given by medical officers.

IMPACT EVALUTION: The feedback from webinars, Geriatric Care Training and regional workshop, we received in our chat box was very encouraging. In Offline Awareness programs also, we had excellent feedback regarding the importance of such programs which created lot of awareness and new vision to look into the issues of Geriatric population because their direct interaction & active participation. The Sr. Citizens informed us that such programs have made positive impact on their mind. The students, educational institutes were tremendously benefitted due to the lectures of doctors, psychiatrists, nutritionist, legal experts, etc. They have requested us for organizing such programs continuously. CSSC-RRTC assured them the advice help, guidance in future.
